Last date for receipt of Application	<p>(a) All applications must reach the office of SQAE (A), KANPUR-208 009 by only ordinary post/speed post within 21 days (closing hours) from the date of publication.</p> <p>(b) In respect of applications received only by post & speed post from the candidates residing in Assam, Meghalaya, Arunachal Pradesh, Mizoram, Manipur, Nagaland, Tripura, Sikkim, Jammu & Kashmir, Lahoul & Spiti District & punji sub division of Chamba district of Himachal Pradesh, Andaman & Nicobar Islands or Lakhadweep or abroad, the last date for receipt of application will be within 28 days (closing hours) from date of publication. GENERAL INSTRUCTIONS: -

- (a) Application will be entertained only in the prescribed format as per **Appendix 'A'** along-with admit card (**in duplicate**) as per **Appendix 'B'**. Application should be forwarded to "**The SQAQ, Senior Quality Assurance Establishment (Armts), Armapore Post, Kanpur – 208 009 (U.P.)**" so as to reach on or before closing date. Envelope containing application must be superscripted in bold letter "**APPLICATION FOR THE POST OF FIREMAN**".
- (b) The closing date for receipt of application is **21 days / 28 days** as applicable from the date of publication of the advertisement in the Employment News.
- (c) Three recent passport size photographs; one duly affixed in appropriate box on the application form duly self attested and another two self-signed, affixed in appropriate box one each on the admit cards.
- (d) Copies of Educational Qualification/Professional Qualification, Proof for date of birth (School Leaving/Matriculation/10th Standard or equivalent certificate indicating Date of Birth), Physically Handicapped certificate, Caste certificate, experience certificate having date of issue and period of Experiences of candidate duly self attested be attached with the application form.

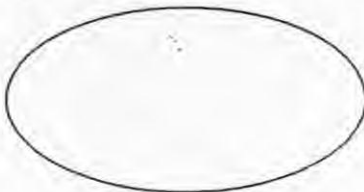
